**SUEN** shares knowledge in the field of water and sanitation, with the ultimate goal to enable water professionals to implement sustainable solutions.

## About SUEN

Turkish Water Institute (**SUEN**) is a national think-tank affiliated to the Ministry of Agriculture and Forestry of Turkey to develop national water policies, provide consultation to decision makers, organise training programs and develop scientific research and strategic ideas with a focus on creating a common platform for water management.

**SUEN** works in close cooperation with national and international water-related institutions on issues such as sustainable water management, water policy development, water governance and capacity building to address local and global water problems.

## Custom-made Training Programs

Since its inception in the end of 2011, more than 1000 participants from over 30 countries attended the training programs organised by **SUEN**. The trainings are designed to meet the specific needs and requirements of the requesting organisations allowing flexibility in terms of group size, training content and duration.

The programs in the form of short courses ranging from 1 day to 4 weeks are specifically tailored to meet each group's needs and can include lectures, case study discussions, group exercises, study tours and field trips to water operators and treatment plants. Participants who successfully complete the programmes are awarded with a certificate.

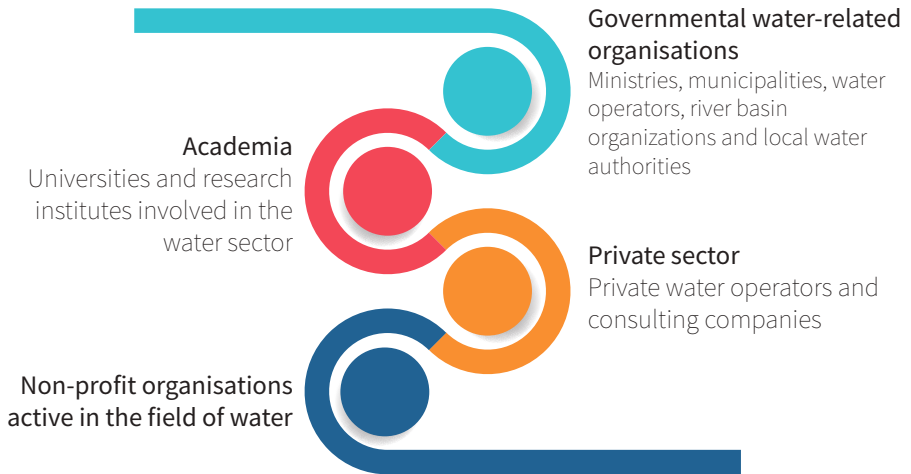

## Some Examples of Tailor-made Trainings

### Multi-Year Capacity Development Program

#### *Azersu*

An extensive custom-made program was developed and implemented in the years 2012 and 2013 involving 240 employees of Azersu JSC, the national water company of Azerbaijan, with the aim to build the capacities of the new generation experts and engineers working in different business units.



## Africa

Sponsored by the Turkish Cooperation and Coordination Agency (TIKA), more than 15 customised training programs related to water and sanitation were implemented to the benefit of African governmental water-related authorities.



## Ergene Basin

12 new advanced wastewater treatment plants were built as part of the "Clean Ergene River" program. **SUEN** played a crucial role in delivering hands-on trainings to the local staff expected to operate the facilities in the Ergene Basin in Turkey.



## South Asia

Short course programs including observational study tours were organised oriented towards the experts representing the ministries in charge of water from the South Asian countries; Afghanistan, Bangladesh, Pakistan and Vietnam.

# How to Apply?

## Step 1

Send your request to [training@suen.gov.tr](mailto:training@suen.gov.tr)  
In consultation with the requesting organisation, an expectation and needs assessment will be done to develop a customised program.

## Step 2

A draft tailor-made training program including the trainers will be shared by **SUEN** with the associated terms and costs. External funding opportunities will be discussed in parallel.

## Step 3

Upon agreement on the program and budget, a formal offer will be submitted to the requesting organisation and if any, funding agency. Logistical arrangements (travel, accommodation etc.) will be arranged by **SUEN** in cooperation with the organisation.

## Step 4

Implementation of the training and joint evaluation at the end of the program.
